- Provide high standards of health and safety.
- Deal fairly with everyone involved in our projects including employees, subcontractors, suppliers and customers.
- Perform to the standards of the NAHB residential construction performance guidelines in effect at the time of construction.
- Offer a minimum one-year written warranty on new homes and remodels, and use MBA's consumer dispute resource program to settle disagreements with builders and remodelers of single family homes should the Association receive a complaint.
- Certify that as a contractor member of Built Green, we are registered, bonded and insured with the State of Washington.
- Use the Built Green logo truthfully and according to the program's logo standards.
